PHARMACEUTICAL ASSISTANCE PROGRAMS

AbbVie — CREON® CFCareForward:

Services offered:

- Co-pay assistance for CREON (pancrelipase)
- Multivitamin coverage
- Medication refill reminders
- Educational emails
- Support hotline

Eligibility:

- Individuals with Exocrine Pancreatic Insufficiency with commercial prescription insurance coverage for CREON (Pancrelipase)
- People with federal, state, or government-funded insurance programs cannot access co-pay assistance or multivitamin coverage

Genentech — Pulmozyme Co-pay Program:

Services offered:

- Co-pay assistance to help cover additional out-of-pocket costs for Pulmozyme, after you pay \$30 for each 30-day supply (Maximum \$10,000/year)

Eligibility:

- Are taking Pulmozyme for an FDA-approved use
- Have commercial (private or non-governmental) insurance
- Live and receive treatment in the US or US territories
- Are not receiving assistance through the Genentech Patient Foundation or any other charitable organization for the same expense

Gilead — Cayston Access Program:

Services offered:

- Provides assistance for those who are uninsured or who have been denied coverage for Cayston
- Those who qualify may also qualify for assistance for additional or replacement parts for their Altera Nebulizer System

Eligibility:

- Meet income requirements
- No insurance coverage, or insured but denied coverage for Cayston

Nestlé Health Science — Live2Thrive:

Services offered:

- Co-pay assistance on eligible Nestlé Health Services pancreatic enzyme prescriptions (12 fills of a 30-day supply or 4 fills of a 90-day supply)
- Free vitamins and supplements
- Loyalty rewards where participants can earn points and redeem them for a variety of nutritional and respiratory health products

Eligibility:

- Individuals with a valid prescription for an eligible Nestlé Health Science pancreatic enzyme
- Residents of Massachusetts, Michigan, Minnesota, or Rhode Island cannot receive rewards through the Live2Thrive program, but may be eligible to receive free supplements and copay assistance
- People with federal, state, or government-funded insurance programs are not eligible for the Live2Thrive program

Vertex Pharmaceuticals — Guidance & Patient Support:

Services offered:

- Co-pay Assistance Program (Maximum \$20,000/year)
- Understanding your insurance plan
- Plan medication refills
- Nutritional & physical activity guidance
- Educational resources

Eligibility:

- Individuals with a Vertex modulator therapy prescription
- Not available to individuals with government-funded insurance

Viatis — PODCARE+ (Tobi Podhaler):

Services offered:

- Insurance coverage reviews
- Therapy support calls as a periodic check-in
- Tobi Podhaler savings card for up to \$14,000/year

Eligibility:

- Tobi Podhaler savings card is not valid for uninsured patients or those who are enrolled in a federal or state healthcare program. Individuals must have commercial insurance.

Viatis — Patient Assistance Program:

Services offered:

- Certain medications may be free to patients with a demonstrated financial need

Eligibility:

- Applicants must be fully uninsured, or if insured, have no prescription drug insurance
- The requested medication must be prescribed by a licensed U.S. healthcare professional for a FDA approved indication

FINANCIAL ASSISTANCE PROGRAMS

The Assistance Fund — CF Copay Assistance Program:

Services offered:

- Copay assistance for out-of-pocket costs for prescribed FDA-approved treatments

Eligibility:

- US citizen or permanent resident who has been diagnosed with CF
- Prescribed an FDA-approved treatment for CF
- Have prescription coverage for the prescribed treatment
- Meet financial eligibility criteria based upon household income and size

Bonnell Foundation — Medical Assistance Program:

Services offered:

- Provides financial assistance that is not covered by insurance or any other program to help cover the costs of: durable Medical Equipment, counseling services, medical care (up to \$500 twice per year), ambulatory services, and CF medications

Eligibility:

- Applicants must provide a letter confirming CF diagnosis
- Provide related bill(s) requesting direct payment

Boomer Esiason Foundation — Patient & Family Assistance Programs:

Services offered:

- IVF Grant
- Financial Hardship Assistance Fund

Eligibility:

- Applicants must be a person with CF, and a US citizen or legal permanent resident
- Must demonstrate proof of financial hardship and consequently cannot meet financial obligations
- Additional eligibility criteria vary depending on program and can be found on website

BreatheStrongCF — Susan C. Burroughs Critical Needs Initiative:

Services offered:

- Provides financial assistance in the form of grocery and/or fuel gift cards

Eligibility:

- Applicants must be an active client of a CF Care Center located in Georgia or be a Georgia resident working with the CF Foundation COMPASS Program
- Be referred by your social worker, case manager, or another member of the healthcare team
- Be experiencing a financial hardship as a result of reduction in income or increase in expenses

Claire's Place Foundation — Extended Hospital Stay Grant:

Services offered:

- One-time financial assistance for families who have someone with CF in the hospital
- Examples include: rent, utilities, and other monthly bills
- Grants range from \$500-3,500/one grant recipient

Eligibility:

- A CF patient or family of a CF patient who have experienced a hospital stay of at least 14 consecutive days within the last calendar year
- Applicants must have a hospital professional (Doctor, Nurse, or Social Worker) submit a referral

The Cody Dieruf Foundation — Medical Assistance:**Services offered:**

- Financial assistance to reduce the financial burden of medical care by covering common costs such as travel expenses to clinics, insurance co-pays, pharmaceutical costs, etc.

Eligibility:

- Applicants must be someone living with cystic fibrosis who require assistance to sustain their medical care.
- Applicants must be living in Montana or be receiving treatment from the Billings Clinics.
- The program is not currently based on financial need.

The Cody Dieruf Foundation — Extenuating Circumstances Support:

Services offered:

- Offers financial assistance for things like emergency housing, meals, and other essential needs when families face unexpected crises

Eligibility:

- A CF patient or family of a CF patient
- Applicants must be living in Montana or be receiving treatment from the Billings Clinics.
- Must show financial need

Cost Plus Drugs — Discounted Medications:

Services offered:

- Company aimed at lowering the price of certain drugs
- Consumers pay for the cost of manufacturing the drug, a 15% markup for each drug the company dispenses, and \$3 for pharmacy labor

Eligibility:

- Currently, prescriptions are only accepted by Capital Blue Cross, Rightway, and a few other prescription plans
- Cost Plus Drugs does not bill Medicare, whether you have a stand-alone Medicare Part D plan or a Medicare Advantage plan with prescription drug coverage. Medications therefore have to be paid for out of pocket.

Cystic Fibrosis Family Connection — Emergency Fund:

Services offered:

- Financial assistance for expenses temporarily beyond a family's means. Examples: lodging for a transplant clinic visit, children's bedding, and baby formula
- Limit of \$500 per year per individual

Eligibility:

- Applicants must be a person with CF with demonstrated financial need
- Applicants are referred via CF clinic social worker, case manager, or other member of care team

Cystic Fibrosis Dreams Fund — General Financial Grants

Services offered:

- Provides general financial assistance through assistance grants to those struggling with the costs associated with cystic fibrosis, usually through direct payment

Eligibility:

- Applicants must be the parent or legal guardian of a minor child with CF or be an adult with CF
- Verification of bill for which you are requesting support

Filotimo Foundation — Cystic Fibrosis Support

Services offered:

- Family Building Support
- Hardship Assistance

Eligibility:

- Family Building Support: Adult with CF with a diagnosis of infertility without children (legally or adopted), without comprehensive insurance coverage.
- Hardship Assistance: Adult with CF experiencing financial hardship receiving treatment at a U.S. pulmonary clinic that partners with Filotimo Foundation.

GoodRX Health — Discounted Medications:

Services offered:

- Compare prices of needed medications and find applicable discounts
- Individuals can use coupons at partnering pharmacies across the US to purchase life saving CF medications at a reduced cost

Eligibility:

- GoodRx cannot be used in conjunction with any US federal or state-funded program like Medicare or Medicaid, however it can be used as an alternative to your private or government-funded health insurance

Healthwell Foundation — Cystic Fibrosis Treatment Fund:

Services offered:

- Cost-share and premium cost assistance for indicated prescription drugs and biologics used by people with CF
- Financial assistance with vitamins and supplements

Eligibility:

- Applicants must be actively receiving treatment for CF in the US
- Have insurance that covers required medications
- Income falls within 500% of the Federal Poverty Level

Services offered:

- Transplant Housing Grant
- Living Essentials Grant

Eligibility:

- Applicants must be diagnosed with a condition that requires organ transplantation and travel to a Bay Area Hospital

Jillian's Jay Walkers — Nutrition & Non-Medical Device Grants:

Services offered:

- Supplemental Grocery Assistance Grant: financial support to alleviate food insecurity for people with CF
- Non-medical device grant: provision of single room, air filter units and/ or humidifiers to people living with CF

- Reach out to the organization for specific eligibility criteria

Live Fearlessly Foundation — Lung Transplant Assistance:

Services offered:

- Offers support for individuals on the lung transplant journey, helping reduce barriers to activities and resources that support physical recovery, mental well-being, and quality of life during the transplant process

Eligibility:

- Verification of CF diagnosis & must be pursuing or navigating lung transplant
- Requests are reviewed and based on individual need, program alignment, and available funding

Services offered:

- Broad financial assistance to individuals or families with CF who are facing financial hardship

Eligibility:

- Applicants must have CF and be a US citizens who reside in California or Arizona

- Be able to provide a letter from your CF doctor confirming diagnosis of disease

Patient Advocate Foundation — Cop-Pay Relief

Services offered:

- Provides direct payment for co-pays, co-insurance, and deductibles for patients who need financial assistance

Eligibility:

- Currently insured with a confirmed diagnosis, and have coverage for medication
- Must reside and receive treatment in the US
- Income at or below 500% of FPL with consideration for the Cost of Living Index and number in the household

Piper's Angels — Urgent Financial Assistance:

Services offered:

- Program to assist people battling CF in need of medically necessary and time sensitive financial assistance, up to \$250 annually

Eligibility:

- Individuals with CF or legal guardians of minors with CF
- Must include a verification letter from one's CF social worker or doctor, confirming CF diagnosis and medically-related financial need

United States Government — Energy Bills Financial Assistance:

Services offered:

- Government programs that help pay for heating, cooling, or home weatherization depending on one's income level

Eligibility:

- Eligibility will vary depending on state guidelines. Please check [your state's eligibility criteria](#).

Vivian Lee Foundation — Family Assistance Program:

Services offered:

- Childcare for sibling during clinic visits
- Loss of income for parents to attend clinic visits
- Loss of income for hospitalization for parents or CF patients
- Living expenses during illness or hospitalization or sickness
- Additional medical expenses after insurance

Eligibility:

- Eligibility criteria will vary based on type of assistance, and amount of assistance will vary per family and per application.
- Families must have verified CF status and may apply for assistance a maximum of 4 times per year (once every 90 days).

SCHOLARSHIPS

AbbVie — CF Scholarship Program:

Services offered:

- An annual offering of \$3,000 to 40 scholars, with one undergraduate and one graduate student selected to receive an additional \$22,000 each.

- Applicants can be full-time or part-time students

- Have a minimum GPA of 2.5
- Be a U.S. Citizen

Patient Advocate Foundation — Scholarship Program:

Services offered:

- National undergraduate, Virginia undergraduate, and graduate scholarships for students who have experienced, or are currently experiencing, cancer or chronic illness

Eligibility:

- Eligibility criteria varies depending on scholarship
- All applicants, across scholarships, must have been diagnosed with and/or been actively treated for a cancer or chronic disease within the past five years. Additionally, all applicants must have proof of an admissions letter

- Provide a breakdown of trade program tuition

BreatheStrong CF — Exercise & Loretta Morris Grants:

Services offered:

- The program provides grants for exercise equipment, organized fitness activities, and facility memberships for people with CF
- Grants do not exceed \$650/year

Eligibility:

- Must be a child or adult with CF living in the United States
- New applicants must submit a medical provider form indicating CF diagnosis

Services offered:

- Applicants must be an individual with cystic fibrosis living in Montana, or a neighbouring state and receiving care at the Billings Clinic.

- Must have a physician diagnosis of CF
- Be over the age of three

- Cannot have had a wish previously fulfilled by another organization

- Have prescription coverage for the prescribed treatment
- Meet financial eligibility criteria based upon household income and size

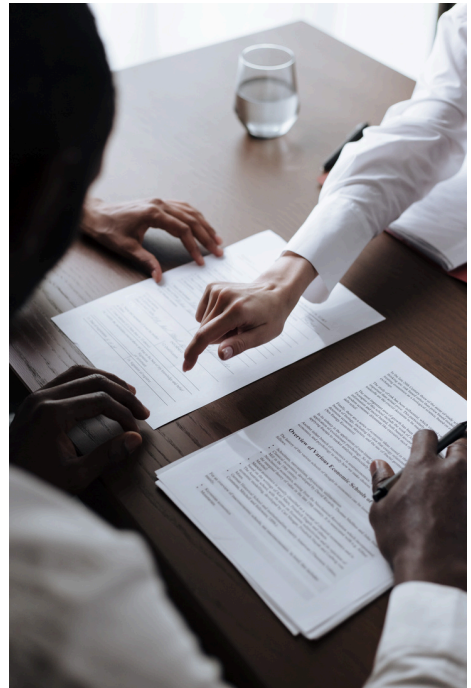
